- 1. Ratification of a Contract Waiver Request by the San Diego Unified School District (SDUSD) of the San Diego Education Association (SDEA) Collective Negotiations Contract to Section 25.5.2. requesting an extension to the deadline of February 16, 2008, to March 7, 2008, for sites to complete the decisionmaking process for the elimination of existing bargaining unit positions, in accordance with Section 3547.5 of the California Government Code and Section 1031 of the Bylaws of the Board of Education. A previous extension of the deadline of February 1, outlined in the Collective Negotiations Contract, was approved by SDEA and adopted by the Board of Education on January 22, 2008. SDEA has approved the waiver request on the condition the Post and Bid schedule for this school year be restructured to include a May Post and Bid and a June/July Post and Bid to allow SDEA members who are excessed due to changes in AA and/or categorically funded positions two opportunities to bid for positions for the 2008-09 school year. - 2. On-Loan Agreements effective March 3, 2008 through June 30, 2008 and July 1, 2008 through June 30, 2009, with the Partnership for Los Angeles Schools for the professional services of Staci Monreal as Academic Leader and Angela Bass as Superintendent of Instruction. Employees will be on-loan to the Partnership for Los Angeles Schools, a nonprofit organization conceived by the Mayor of Los Angeles, to join efforts with Los Angeles Unified School District (LAUSD) in accelerating achievement in chronically underperforming schools in Los Angeles. One of the goals of the collaboration between the City of Los Angeles and LAUSD is to directly support and manage a family of schools which will be composed of high schools, middle schools and the elementary schools that feed into them.

The employees will be on-loan for the remainder of the school year 2007-08 and the 2008-09 school year. The District will be reimbursed for their salaries and fringe benefits for the remainder of the 2007-08 school year in the amount of \$79,862.14 for Angela Bass and \$62,768.02 for Staci Monreal and reimbursed for the 2008-09 school year in the amount of \$237,663.11 for Angela Bass and \$186,780.39 for Staci Monreal.

- 1. Approval of the Memorial School campus as the location for the new Millennial Tech Middle School (MTM). The MTM school, planned to open in the Fall of 2008, will offer a Science, Technology, Engineering and Mathematics (STEM) program. The school program will be funded through the Magnet Schools Assistance Program Grant (MSAP). The school was part of the Magnet Schools Assistance Program Grant Application, approved by the Board of Education on March 27, 2007, and awarded by the Federal Government in September of 2007. The 2007-08 school year represents a planning year, during which the District is required to make a careful analysis of location options and determine a campus for the new Millennial Tech Middle School. This report discusses three viable campus options and brings forward a recommendation for the Board's consideration and action. [Exhibit] [Originator Office of School Choice]
- 2. Preliminary Offers for Allocation of Facilities for Charter Schools Under Proposition 39 (Education Code Section 47614) for the 2008-09 School Year.

The District received request(s) from the following 19 charter schools to occupy District facilities for the 2008-09 school year: Albert Einstein Academy Charter School; Albert Einstein Academy Charter Middle School; Darnall Charter School; Gompers Charter Middle School; Harriet Tubman Village Charter School; Health Sciences High and Middle College Charter School; Iftin Charter School; Keiller Leadership Academy; King/Chavez Academy of Excellence Charter School; King/Chavez Arts Academy Charter School; King/Chavez Athletics Academy Charter School; King/Chavez Preparatory Academy Charter School; King/Chavez Primary Academy Charter School; KIPP Adelante Preparatory Academy; Memorial Academy of Learning and Technology Charter School; Momentum Middle Charter School; O'Farrell Community School; Promise Charter School; San Diego Cooperative Charter School.

Proposition 39 (Education Code section 47614) requires the District to offer reasonably equivalent facilities to charter schools that show that they are eligible to receive such facilities. Staff has analyzed each of the requests in conformity with the requirements of Education Code section 47614 and the implementing regulations and has developed recommendations for responding to each of the requests, as well as for the preliminary offers of facilities for eligible charter schools. Staff is submitting this report and its recommendations for Board approval and requests the Board adopt the report as its statement of reasons.
